## **2022 VETERAN SUPPORT**



#### "Karl" - US Marine Corps Veteran

"Karl" was a decorated US Marine with ten years of service, rising to the rank of Gunny Sergeant (E-7). He is struggling with the transition from military service and parental responsibilities. Karl suffers from losing mental focus and disorientation. He recently was threatened with eviction due to significant overdue rent. Luke Chapter's grant helped Karl and his son keep their home and retain hope for the future.

#### "Lucy" - US Air Force Veteran

"Lucy" entered the US Air Force from the Navaho Reservation as a young woman after being raised in foster care. She served honorably in admin support as a "Chair-borne Ranger" as she told us. Lucy lives in an RV in Show Low, Arizona, which required major, costly repairs to keep habitable. She could not then afford sufficient propane for the winter. Sometimes water froze inside at night. With our



grant, she will have enough propane to stay warm this winter. Lucy told us: "Thank you very much sirs and ma'am! I really appreciate all of you guys and gals helping me with this assistance.... I'm sending big virtual hugs to each and every one of you. You all are a great blessing to me and my pooch. Again, thank you ... and I'll keep you all in my prayers. Thank you for your service to our country!!!"

Everett Hines, Texas A&M University. He was home schooled. He will be attending Texas A&M University in the fall where he will major in history. After graduation he plans to pursue a military career in the Army. He was awarded \$4,000.
