Brigadier General John Conley is the Adjutant General of Arizona and Director of the Arizona Department of Emergency and Military Affairs, at Joint Force Headquarters, Papago Park Military Reservation, Phoenix, Arizona. He is responsible for leading Arizona's Army and Air National Guard, Joint Programs, and the Division of Emergency Management. Brigadier General John Conley oversees an 8,300-member department, of which 2,400 are fulltime federal military and civilian personnel, and 600 are fulltime state employees.

Brigadier General Conley earned his commission as a Second Lieutenant through Army ROTC, Northeastern University, Boston, MA in June 1992. After graduating from the University of Arizona College of Law, Brigadier General Conley attended the Army Judge Advocate Officer Basic Course in Charlottesville, VA in 1996. He served on active duty as Legal Assistance attorney and later Trial Counsel at Camp Humphreys Army Airfield, Korea. He was assigned as Trial Counsel and later Labor Counselor at Wiesbaden Army Airfield, Germany.

After leaving active duty, Brigadier General Conley served as Executive Officer and later Officer

in Charge of the largest Army Reserve legal support team in Arizona. In March 2011, Brigadier General Conley transferred to the Arizona Air National Guard. He was the senior legal advisor to both the Air Component Commander, Arizona Air National Guard, and The Adjutant General, Arizona. He directed all Air and Army Judge Advocates, DEMA civilian counsel, and paralegals in the performance of their duties. Brigadier General Conley oversaw Air and Army military justice, operational law, civil law, fiscal law, cyber law, and ethics functions at all command levels. Prior to his current position, Brigadier General Conley served as the Director of Administrative Services, DEMA, Phoenix, Arizona where he managed a broad spectrum of personnel, finance, and mission support functions for the Arizona National Guard and Division of Emergency Management.

The Art of Active Listening



You've heard these phrases many times before: "You've been given two ears and one mouth for a reason." "No one ever listens to me." "If that guy would just shut up and listen for a minute, he might learn something." "Listen to what I'm telling you!" Listening

is something we have done all of our lives, but far too often people want to go into "transmit" mode instead of "receive," as they believe what they have to share is more important/relevant/timely/etc. than what they're hearing. So, let's talk about the art of active listening and the value it brings to any conversation.

Active listening doesn't mean "don't talk." It means initially giving all of your attention to the person speaking; really focus on what they're saying; don't rush them; don't interrupt. Make direct eye contact; watch your body language. Let their words sink in. Not only can you learn facts, you can learn the emotions of the speaker, which may provide you with greater insights than the words themselves. OK; they're done; now it's your turn. Don't immediately change the subject; that tells the other person that you either didn't understand what they were trying to convey or, worse, that you don't care. Ask them to go into greater detail on some aspect of the information they were trying to share. Ask a question. Ask another one. When they feel that they have shared everything they wanted to, they'll stop. But they'll stop knowing that you truly heard and understood everything that they were trying to convey, and they will feel valued.

Active listening is a learned skill; you won't be good at it on the first try. Our tendency to want to speak easily overpowers our desire to listen. But your friends and family will truly appreciate your new skill. And who knows; you might learn something!

OUTREACH -- WHAT'S NEW?

The Luke Chapter Casualty Assistance information is an amalgamation of multiple website sites supporting all uniformed services. In order to make it easier to access information, in a one-stop-shop, the information was pulled together into one document on the Luke Chapter MOAA website. In addition, the final document has been printed and bound in a cover for distribution to assisted living residences where veterans may live. The facility person responsible for assisting the grieving family is identified and the booklet is delivered to that person.

Since there are 2 Retired Activities Offices (RAO) at Luke, we will share this information with both. We will also distribute the booklet to multiple Long Term Care residences that house veterans. A list has been generated and 5 facilities are targeted each year for receipt. If a family experiences a loss and the facility does not have this information handy, a phone call to Linda Wolverton – 623 505 7244, will resolve this.

Veterans' Last Patrol program will continue throughout this year. This is a national program where we, Surviving Spouses, will sign 'Thank You for Your Service' cards for veterans in hospice who have no family. The cards will be annotated by our members at each luncheon and then sent to The Veteran's Last Patrol group in South Carolina. That group will then send the

cards to veterans who meet these criteria throughout the country.

We had a wonderful lunchtime with Mary Helen Melton at the Grandview Terrace. Thank you, Mary Helen, for entertaining us!

We also assisted a member's family when our beloved member sailed west. We were grateful to have the opportunity to meet and work with his wonderful family.

The Surviving Spouse Luncheon –

Tuesday, October 7, 2025 at 11:00 AM

Our luncheon was held at the Goodyear Haymaker. It's our first SS luncheon meeting of the year. There we met 4 new members: Kathy Upchurch from the Arizona Chapter, Sally Brauer, and Donna Fischer from Sun City, and Karen McVay from Goodyear.

We heard from LTC Rick Griset, former Luke AFB's historian. He shared how a piece of farmland grew into Luke AFB. On 31 March 1941, months before the United States entered World War II, construction began. That summer, the Army Air Corps named the air field Luke Field after World War I hero and triple ace Frank Luke Jr.

Some pilots from Luke Field's first class flew from airfields in Hawaii during the Japanese attack on Pearl Harbor.

Annual Trip – is in the planning stages.

We are planning on visiting Falcon Field. Before World War II, Hollywood producer Leland Hayward and pilot John H. "Jack" Connelly founded Southwest Airways using funds from friends including Henry Fonda, Fred Astaire, Ginger Rogers, James Stewart, and Hoagy Carmichael.

At that time, Southwest Airways operated Falcon Field to help train pilots from China, Russia and 24 other Allied nations. Falcon was to be Thunderbird Field III and eventually would train British pilots.

Our paperwork has been submitted to the Docent at the Commemorative Air Force Museum at Falcon Field. If the visit is approved, we request that all attendees wear slacks because of the possible B-17 onboard tour of the Flying Fortress.

Following approval, I will share destination, transportation information, lunch information and other activities to help with your planning of the date and time.

Board Briefs

Luke Chapter (LC) and Community Fund (CF) October 2025 Board Meetings



- Both Luke Chapter and Community Fund held board meetings the week of 29 September.
- Our President, Gene Wikle, was hard at work recently supporting emergency relief efforts in his job with the State of Arizona to help the Globe area after a devastating recent flood.
- Jack Coate reported that the current asset balance of Luke Chapter (LC) on 30 September 2025 is \$42,326, of which \$23,882 is unrestricted equity.
- Assets of Community Fund on 30 September 2025 stand at about \$74,000, after paying scholarship grant awards of \$30,000 in mid-September. We are positioned as we lean in to fund-raising activities this fall.
- Ed McAvoy led Community Fund for five years with vision and vigor -- thank you kindly, Ed! And thank you, Shanna Woyak, for accepting the role of President of Community Fund going forward.
- Craig Quigley said the Chapter will hold dinner events at the Colonnade in October, November, and December. He is developing a schedule for spring that combines traditional evening dinner meetings and occasional informal lunches.
- Rev Fannalou Guggisberg will again lead our Chapter food and gift card donations in the Turkeys for Troops program at Luke AFB. Donations are requested by chapter members no later than mid-November for delivery to the base.
- The PebbleCreek Nine Hole Men's Golf Club, in conjunction with Luke Chapter, is supporting a golf tournament in Novem-

ber that will solicit food donations for Turkeys for Troops.

- Mike Kramer reported that the Veterans' Relief Grant program will move forward with about \$22,000 in combined Chapter and CF funding. This is roughly one-half of the amount spent in the veterans' program last fiscal year. See nearby article for more details.
- The long and complex Form 990 tax return was approved for filing with the IRS by the Luke Chapter Board. The tax return for the Community Fund is in preparation and will be filed soon. As tax exempt non-profit entities in good standing, no taxes are due to the IRS or Arizona.
- Community Fund approved a budget allocation of \$30,000 for scholarship grant awards next spring. That amount may grow or shrink depending on the success of our annual fund drive.
- Ben Hayes reported that Luke Chapter now has 154 active Members on our roster, including 113 Regular Members and 34 Surviving Spouses, with 3 "Honorary" persons. Ben is working to reconcile our Chapter roster with the MOAA roster. Linda Wolverton expects 3 new SS members.
- Linda Wolverton reported on plans for a luncheon 7 October by the Surviving Spouses. The historian at Luke AFB, Lt Col Rick Griset, will lecture and show photos about the history of Luke AFB. Also, Linda applied her knowledge of DFAS pay practices to avoid a 'claw back' of retirement pay transferred to a member who passed away recently.
- Buz Isban is liaison and Secretary of the NW Valley Veterans Association. He provided a calendar of dates for programs and events involving active duty and former military members. Buz is also engaged as liaison with the JROTC programs in 13 high schools in the West Valley. Recognition certificates will be awarded to the students in the spring.

Helping Needy Vets

Luke Chapter Funds A Strong Veterans Grant Program

Our Veterans' Relief Grant Committee paused its activities over the summer but is now back in full swing. The volunteer team of Beth Johnson, Mike Byers, Ron Walk, Jack Coate and Mike Kramer, and our loyal panel of interview volunteers, are now in action to assist veterans with serious housing related financial emergencies.

The Luke Chapter Board funded the program with \$4,801, and the Community Fund Board allocated \$17,551, for the current fiscal year. The two budgets will allow about \$22,400 in grants to individual vets, and for food relief at Luke AFB. Commissary gift cards of \$60 each will be purchased for distribution in the annual Turkeys for Troops program at Luke AFB. Rev Fannalou Guggisberg, our Chaplain, is again leading the canned/package food donation drive for donation to needy active-duty members and their families at the base. In addition, the Pebble-Creek Nine Hole Men's Golf Club will solicit food donations for the base, in conjunction with Luke Chapter.

Last year, our Chapter spent a record \$40,350 in direct grants to individuals and for commissary gift cards. Most of the canned/package food is donated by our members and is not purchased by the Chapter. Cases are referred to us primarily by counselors at the Veterans Administration and the Arizona Coalition of Military Families (BeConnected).

As noted, the funds available to us this year are about one-half the amount granted last year. We no longer receive grant funding from the Arizona Department of Veterans' Services, due to onerous new program restrictions and bureaucratic reporting burdens. We are largely dependent upon our own Chapter members for donations. Also, we decided to continue the grant work at a lower level-of-effort that our

small volunteer cadre can sustain. We are proud of our highly regarded program.

The need for housing support by Arizona veterans is large and growing. Indeed, we have already approved grants in late September for two indigent, unemployed veterans. "Pete", an elderly gentleman in poor health, was interviewed using Zoom while lying in a hospital bed at the VA Clinic. We paid three late mortgage payments totaling about \$1,700 to keep a roof over Pete's head. Payment of this grant was made within a few days of approval of the grant.

Likewise, a grant check for rent due on 1 October was delivered to veteran "Oliver" only one day after the committee interviewed him and approved the grant.



This avoided a daily \$100 fine had the rent been paid even one day late. Our energetic Treasurer, Jack Coate, hand-delivered the rent check to Oliver at a restaurant across town. Jack even bought lunch for Oliver! Needless to say, Oliver was a happy man and very grateful to Luke Chapter for keeping his home intact.

As veterans, we will never stop helping our fellow comrades-in-arms. Our Chapter motto is:

Never Stop Serving
